Each panel shall consist of two lawyers and one nonlawyer as
designated by the Commission. The Administrator may institute
disciplinary or unauthorized practice of law investigations
and proceedings related to the out-of-state attorney.
A second or subsequent violation is a Class 4 felony. One member may
hold the office of both secretary and treasurer. Upon such
registration, the attorney shall be placed upon retirement
status and shall no longer be eligible to practice law or hold
himself or herself out as being authorized to practice law in
this state, except as is provided in paragraph k of this rule.
